Pursuant to the Law on the Ratification of the Loan Agreement (IBRD Loan No. HR-9127) between Republic of Croatia and the International Bank for Reconstruction and Development for financing of the Earthquake Recovery and Public Health Preparedness Project (NN MU No. 4/2020), the Project Implementation Unit publishes the following notice:

Contract Award Notice

Procurement of Reconstruction Works for Clinical Hospital Center Zagreb - Rebro III Phase

The Republic of Croatia (RoC) with financing from the International Bank for Reconstruction and Development (IBRD) through the Loan Agreement (Loan No. 9127-HR) is implementing the Earthquake Recovery and Public Health Preparedness Project (Project). Project Development Objective is to assist Croatia with earthquakes reconstruction efforts. Under the Project prequalification for works was initiated on July 21st, 2023, by publishing of the Invitation for Prequalification in Official Gazette no. NN 83/2023. Seven Applications were received and after thorough examination five of them were evaluated as prequalified. On May 16, 2024, Request for Bids was issued to prequalified applicants.

Bidding was conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, revised November 2017 and August 2018 ("Procurement Regulations") and was open to all prequalified eligible Bidders.
